MARY'S COLLEGE, No. C0009540, incorporated November 16, 1871; (7) GERMANIA CONCLAVE NUMBER 83, OF THE INDEPENDENT ORDER OF THE SEVEN WISE MEN (I. O. S. W. M.), No. C0003659, incorporated March 21, 1872; and (8) BENEVOLENT PROTECTIVE ORDER OF SEALS, No. C0000831, incorporated August 9, 1873. These have been omitted from the above table.
